

## MATES MONTH | Australia's Greatest Mate

### TERMS AND CONDITIONS

---

#### The Competition

1. 'AUSTRALIA'S GREAT MATE' competition is open to eligible Australian residents who are aged 18 years and over and excludes ineligible persons identified in clause 11 of these terms.
2. Nominated winner will be required to present proof of age before delivery of the prize.
3. These Terms and Conditions form part of your entry to the competition. Entry into the competition is deemed acceptance of these Terms and Conditions.
4. The competition commences at 9:00am AEST on Monday, 2 July 2018 and will end at 12-midnight AEST on Monday, 30 July 2018 (**Promotional Period**). Entries received after this time will not be included in the competition.
5. The promoter of this competition is Mates4Mates Limited (ABN 54 160 646 999) of 27 Douglas Street, Milton 4064 (**the Promoter**).
6. The Promoter reserves the right to extend, withdraw or cancel the competition or amend these Terms and Conditions at its own discretion without any obligation to notify or compensate entrants.

#### Eligibility Criteria

7. To be eligible to enter and win the 'AUSTRALIA'S GREATEST MATE' competition, entrants must go online during the Promotional Period to [www.greatestmate.com.au](http://www.greatestmate.com.au), complete the competition form and answer the question "Who is your greatest Australian mate and why?"
8. All entries must include the correct contact details including name, email and/or phone number of the entrant and their nominee for Australia's Greatest Mate.
9. All entries must be unique and original and not contain extracts from any published material.
10. To be eligible to win, the nominee must accept the entrant's nomination via email or phone, in accordance with clause 18.
11. Employees (and their immediate family) of the Promoter are ineligible to enter and win this Promotion and cannot be nominated by any entrant.

#### The Prize and Winning

**NO LIABILITY**

24. The Promoters and its related bodies corporate shall not be liable for any loss or damage whatsoever which may be or is suffered (including but not limited to direct indirect, special or consequential loss) or for any personal injury suffered or sustained in connection with any prize/s except for any liability which cannot be excluded by law. Neither is the Promoter and its related bodies corporate responsible for any incorrect or inaccurate information, either caused by the entrant or for any of the equipment or

programming associated with, or utilised in this Promotion, or for any technical error, or any combination thereof that may occur in the course of the administration of this Promotion, including any omission, interruption, deletion, defect, delay in operation or transmission, communications line or telephone, mobile or satellite failure, theft or destruction or unauthorised access to, or alteration of, entries, and reserves the right to take any action that may be available.

If for any reason, the Promotion is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any other causes beyond the reasonable control of the Promoters, which corrupt or affect the administration, security, fairness, integrity or proper conduct of this promotion, the Promoter reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, take any action that may be available and to cancel, terminate, modify or suspend the Promotion subject to any written directions given under State Legislation.
26. Except for any liability that cannot be excluded by law, the Promoter and its related bodies corporate (including their officers, employees, contractors and agents) excludes all liability (including negligence) for any personal injury or loss or damage (including loss of opportunity) whether direct, indirect, special or consequential, arising in any way out of the Promotion, including but not limited to, where arising out of the following:
  - a) Any technical difficulties or equipment malfunction (whether or not under the Promoters' control);
  - b) Any theft, unauthorised access or third-party interference;
  - c) Any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter;
  - d) Any variation in prize value to that estimated or stated in these terms and conditions;
  - e) Any tax liability incurred by a winner or entrant;
  - f) The broadcast of any program relating to the Promotion or the publication of any material, including statements made by any compere, staff member, journalist, other entrants or any other person; and/or
  - g) Participation in the prize.
